Damage Waiver:

The customer acknowledges to pay the renter a surcharge of (9.9% currently) to be exonerated to pay for damages to the rented equipment resulting from a mechanical breakdown. Damage waiver in not an insurance, this does not replace an "all risk insurance" that the lessee must maintain on the rented equipment at his own expense. The damage waiver does not remove any right to the insurer to subrogation. The damage waiver does not apply in the following situations:

- Damages resulting from weight surcharge in excess of manufacturer of the rented equipment or accessory
- Tipping due to uneven weight distribution of load
- Tire puncture, slashed tire, damaged wheel rim, damaged blade, bit and fish cable
- Equipment left unattended either inside or outside of site
- Frost, lack of lubricating oil, lubricant, lack of or wrong fuel or combustible
- Abuse, collision on private or public road/property
- Customer neglect
- Equipment usage or modification for purposes other than those recommended by the manufacturer

Environment Fees:

To keep in good working order our rental fleet, LOU-TEC must handle and dispose of hazardous products. To conform to environmental rules, fees will be added to all invoices for the treatment and the safe disposal of these products (current rate). These fees are not a government tax, it represents the costs to offset the treatment of oils, batteries, fuels and other contaminants in respect of the environment.
